

## COOPERATION FRAMEWORK AGREEMENT BETWEEN INTERWEAVE SOLUTIONS AND

Between the official parties of this document, namely: **Dean Curtis**, with identification of US Passport N° 561402486, and with residence and address in the city of Ogden, Utah, who acts in name and in representation of the organization **INTERWEAVE SOLUTIONS**, with primary residence of organization in Provo, Utah, United States, who from now on and for all intents and purposes of this contract will be known simply as **INTERWEAVE**, for one part, and for the other part \_\_\_\_\_, of legal age, with residence and address in the city of \_\_\_\_\_, identified with citizenship documentation \_\_\_\_\_ issued in \_\_\_\_\_, who acts in their own name and legal representation, will from now on will be called \_\_\_\_\_ throughout the document.

### CONSIDERATIONS:

1. That \_\_\_\_\_, with the support of **INTERWEAVE**, will offer the **MBS, MASTER OF BUSINESS IN THE STREETS** (for the general public) whose main objective is to combine efforts to improve the quality of life of the population in vulnerable conditions, promoting business ideas and strengthening existing businesses, and thus lead them to self-reliance through an educational process.
2. That \_\_\_\_\_, with the support of **INTERWEAVE**, will train a group of people, in all the regions of \_\_\_\_\_ in order to help them become self-reliant in the fields of business, family, and the community.
3. That \_\_\_\_\_ will seek to contribute to the strengthening of the social fabric of the city in their regions of \_\_\_\_\_ through educational programs of self-reliance for the creation of business ideas and the strengthening of current businesses so that the businesses are sustainable and competitive.
4. That \_\_\_\_\_ and **INTERWEAVE**, understand and consider that the mayors, government officials, and governments also work with these same objectives in mind and will strongly consider creating contracts and working with the people of this field.
5. That every participant that finishes the self-reliance program will receive a graduation certificate from **INTERWEAVE** with the name of **MASTERS OF BUSINESS IN THE STREETS**.
6. That \_\_\_\_\_ and **INTERWEAVE** have identified similar elements of cooperation within their own selves/organizations to develop a cooperation between the organizations. They are in agreement that it is for the benefit of both organizations to join forces and develop mechanisms of cooperation and inter-agency support for the joined purpose of both organizations.
7. That the rights and materials from the program of **MBS (MASTER OF BUSINESS IN THE STREET)**, cannot be used without the authorization of **INTERWEAVE**.

Taking into account the previous considerations, the parties agree to uphold the agreements and be governed by the following clauses:

**FIRST: PURPOSE OF THE CONTRACT:** The general purpose of this contract is to state actions, efforts, abilities and knowledge, emphasizing self-reliance and the abilities required in order to better develop **BUSINESSES, HOMES, and COMMUNITIES**. This will help improve quality of living conditions in regards to the vulnerable population of \_\_\_\_\_. Training topics include business, creating and improving business, the creation of sustainable businesses and all other business training in regard to these topics. And as part of the training process, included is the training and promotion of people identified as potential beneficiaries of the Interweave self-reliance program.

**SECOND: SPECIFIC OBLIGATIONS OF EACH PARTY.**

**A. ON BEHALF OF INTERWEAVE:**

1. Transfer the methodology of the Interweave Self-Reliance Program to \_\_\_\_\_ through personal training previously agreed upon by both parties.
2. Provide the availability of training MBS materials of every participant and facilitators for the self-reliance groups.
3. Deliver the **MBS- MASTERS OF BUSINESS IN THE STREETS** graduation certificate to the partner entity in behalf of each participant who has completed all of the requirements of the program.

**B. ON BEHALF OF \_\_\_\_\_:**

1. Create self-reliance groups to participate in **MASTERS OF BUSINESS IN THE STREETS** course.
2. If training a third party, \_\_\_\_\_ has the responsibility to select the people from the third party organization that will be receiving the methodology training from Interweave for the Self-Reliance Programs.
3. Complete a Pre and Post evaluation of each participant and complete a Success Ambassador self-evaluation, in accordance with the rules and guidelines of Interweave Solutions.

**THIRD: COORDINATING COMMITTEE:** The parties agree to integrate a Coordinating Committee for the contract, which shall be integrated in the following manner: one (1) official appointed by INTERWEAVE and one (1) official appointed by \_\_\_\_\_:

**FOURTH: RESPONSIBILITIES OF THE COORDINATING COMMITTEE:**

The duties and responsibilities of the Coordinating Committee are the following:

- A. Supervise the implementation of the Program to ensure that the developments are in accordance with this contract and agreement.
- B. Hold quarterly evaluation meetings on the progress of the actions agreed upon.
- C. Present quarterly reports of the progress of actions to the legal representatives of the signatory entities.
- D. Conduct a general assessment every six months on the progress of the contract and agreement.

**FIFTH: TERMS OF THE DURATION OF CONTRACT:** The present contract will have a term of duration of four years, El presente convenio tendrá un término de duración de cuatro años, counted from the date of signature of both parties. This remains true as long as the ambassador complies with the requirements established by Interweave to be a Success Ambassador. However, it may be extended by mutual agreement, provided that they mediate mutual communications from both parties with the intent of extension and subscription of the respective act.

**SIXTH: CAUSES OF THE TERMINATION OF CONTRACT**

The following would be reasons to terminate the present contract:

- A. The expiration of the agreed period, except for the provisions of the previous clause.
- B. The mutual agreement between the parties, expressed in a document signed by the legal representatives of the entities.
- C. The technical, administrative or legal impossibility to continue with the implementation of the contract.
- D. The occurrence of circumstances of a fortuitous case or greater force that impedes the continuation of the contract.

**SEVENTH: RELATIONSHIP BETWEEN THE PARTIES:**

As a result of the present contract \_\_\_\_\_ can offer Interweave's Self-Reliance Program to third parties. The values of this program will be measured by \_\_\_\_\_ according to the criteria of negotiation, as long as the values that INTERWEAVE has set forth are not altered.

**EIGHTH: USE OF CORPORATE IDENTITIES:** The communications and documents that result in the implementation of this contract will allow the use of its corporate image, but this does not imply the assumption of solidarity obligations between them.

**NINTH: PERFERCTION AND EXECUTION.** This contract is understood to be perfected on the basis of its subscription. In constancy, it is signed in the City of \_\_\_\_\_ on the day\_\_\_\_\_.
